<p>課程宗旨： Course Objectives</p>	<p>本課程旨在培養學生在 IFRS 架構下進行財務報表分析與企業評價的能力。課程內容涵蓋策略分析、會計分析、財務分析與前景分析，協助學生理解如何運用財務報表及各類可取得資訊評估企業整體表現。透過這些分析能力，學生得以應用於個股分析、信用評等、企業併購評估、IPO分析、以及企業負債與股利政策的判斷。課程將以八個指定課本個案進行課堂討論與解析。第14週時會安排一次完整的綜合個案分析，整合前述分析工具，評估個案公司的目標股價與信用評等，以達到理論與實務並重之學習成效。</p> <p>This course equips students with the knowledge and skills necessary to conduct comprehensive business analysis and valuation. Through a blend of theoretical frameworks, practical applications, and real-world case studies, students will develop proficiency in analysing financial statements, forecasting future performance, and determining the value of businesses. It will discuss topics such as business analysis, accounting analysis, and financial statement analysis. This course aims to develop students' capabilities of critically evaluating financial reporting issues, conducting equity analysis in the context of IPOs and M&amp;As, and providing informed insights to stakeholders such as equity investors and corporate lenders.</p>
